Review of Minutes from March Meeting:

- Reviewed the 5th Quarter rules
- 5th Quarter changes discussed; agreed-upon modifications to UYFL 5Q Rules:
 - Coaches permitted to be on the field at all levels
 - Announcer / stick crew must be part of 5th quarter.
 - No blitzing allowed. (Needs to be added to All Star game)
 - 4 qtrs. (8-minutes each, running clock)
 - Possession changes each quarter (16 minutes offense / 16 minutes defense)
 - o 1 timeout per team, not including injury timeouts
 - Start on 30-yard line with each possession
 - o Home team gets the ball first
 - Score will be kept as normal
 - One-hour time limit; if it goes longer, both organizations need to agree to keep playing (ex. injuries / weather).
- 5Q changes were added to the updated rules and sent to all organizations with the March meeting minutes

Treasurer's report:

- 2024 Dues:
 - Total Expenses: \$23,422 (Last year's budget +10%)
 - Total Team Dues: \$23,436 (Last year's dues +10%; \$558 per team)
 - Referee fees are not increasing this year
 - Breakdown of budget included in attachment to meeting minutes
- All teams provided checks for dues
 - PR will provide an additional \$558 check for a 7th team (increasing from 2 to 3 teams at 12U)

Refs Association:

- Increase from \$25 to \$60 for 5th quarter officiating
